Reallocation RFI results	Westhab was Board selection for the reallocation project for this year's NOFA. The project will be an expansion of the DCMH RAP project; DCMH and Westhab continue to work with Greyston to transition current prioritized Issan House residents.

Coordinated Entry COVID19 policy review – update	 Yoav Spiegel initiated discussion on changes to coordinated entry prioritization and review of recent COVID19 policies. Craig Wong reported on the progress staff have been making. Staff continues to try to enter relevant information. Jomarie Tarchoun, DSS, reported no new referrals from updated prioritization list, (no permanent housing score of 5 or higher that have high risk factors of COVID19).

New York State budget cuts planning (NYS OMH)	 Annette Peters Ruvolo gave an update on NYS OMH budget withholds to state aid funding, which impacts the supportive services for some of our HUD projects (the largest being the DCMH RAP). DCMH plans to shift funding from rental assistance to supportive services to make up for the shortfall. Anahaita Kotval, Lifting Up Westchester, raised concerns with housing inspections for RAP and Turning Point projects. Due to the storm, homes have experienced power issues for two weeks. Home repairs have not been made and fear consequences. Yoav believes HUD 30 day limit for home improvements is absolute. Annette requested that specific circumstances be brought to their attention.

ESG Priorities	 Karl Bertrand, Co-Chair gave an update on ESG priorities. Street outreach numbers are high, auto exit implementation has helped shelters declutter their system. Mt Vernon and Yonkers are looking to de-densify by moving high risk people out of congregate shelters. Yonkers considering targeting prevention funding to recently homeless. Judy Mezey, the City of White Plains, will do additional research on CDBG funds and if they can be used for planning. Judy Mezey, the City of White Plains, discussed eviction prevention program models. Judy provided Triece with the contact information to the lead on the eviction prevention program models- Susan McMahon. Karl will write up recommendations to be widely distributed.
