PIT Count 2020 Updates	<ul> <li>This year's PIT Count included a total of 47 volunteers making up 18 teams that went out to count individuals currently experiencing street homelessness.</li> <li>There was a debrief PIT Count meeting with the team leaders who provided suggestions on improvements to next year's PIT Count. The team agreed that teams should be sent out at a later time encounter more people.</li> <li>In total 67 individual were found to be homeless. Half were by observation only.</li> </ul>
	<ul> <li>The information received by the teams that night (names/descriptions) were given to the Street Outreach Workgroup by area.</li> <li>Judy Mezey commented on how helpful the White Plains Police Department</li> </ul>
	was during the PIT Count. Also, the White Plains team leader was very skilled in knowing how to approach individuals who may be homeless.
	<ul> <li>Craig Wong was on the Mount Vernon team and agreed that having buy in from the Police Department was very helpful with finding areas to look for people who are homeless. The councilwoman on the Mount Vernon team was able to collaborate with the Police Department.</li> </ul>
	<ul> <li>Yoav Speilgel, DCMH Program Specialist shared the data found. Most of the homeless individuals found on the night of the PIT Count were sheltered. All shelter staff needs to quickly respond to any data correction requests. Five sites have not submitted as of yet.</li> </ul>
