DCMH has been delayed in submitting claims to HUD for the current DCMH Vet Home 03 grant NY0888L2T041807 because the subrecipient agency took several months to return the executed subcontract with DCMH - and so did not submit vouchers until over 5 months into the operating period, which then needed review to ensure that the claims entered into LOCCS were completely accurate.

In addition, these problems were compounded by internal staff turnover at DCMH; the primary staff person responsible for reviewing CoC vouchers left DCMH, and the replacement hired also left after a very short time.

DCMH is working to resolve both of these issues. A new staff person has now taken over review of CoC vouchers.

DCMH is working with the subrecipient to ensure that vouchers are submitted for review in a timely manner going forward.

The FY2017 grant DCMH Vet Home 03 NY0888L2T041605 had a large remaining balance of \$40,812 in Rental Assistance.

Individuals served by the project may be experiencing substance abuse issues as well as other disabling health conditions. Westhab, Inc. is the sub-recipient administering this project on behalf of The Westchester County Department of Community Mental Health (DCMH). Westhab has extensive experience providing housing and other services to persons with mental health and/or substance abuse issues, and has demonstrated a capacity to deliver quality care. The sub-recipient meets regularly with DCMH contract management staff/CoC members and VA staff to develop and monitor plans to effectively identify and address the needs and issues of the veterans served by this project, and to remain aligned with the overall goals of the CoC. DCMH, acting as grantee for this project, conducts annual monitoring visits to ensure adherence to HUD regulations in administering the project. Findings are reported back to the sponsor agency and follow-up is conducted as needed.

Supportive services are primarily delivered by the VA Hudson Valley Health Care system in partnership with the subrecipient agency and WC DCMH. Also numerous mental health, substance abuse, health, vocational, advocacy and school- and community-based programs throughout the county provide supportive services to facilitate success in each individual's recovery process.
