3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

HOPE's CNR Rehousing Initiative provides permanent housing subsidies, case management, crisis intervention and housing retention services to 12 homeless disabled homeless adults from New Rochelle. The urgent need for this program has become clear through the growing numbers of unsheltered homeless people using our soup kitchen. We're also working closely with the OASIS shelter, New Rochelle's only low-demand emergency shelter. Originally planned with a capacity of 10 people, OASIS now has 35-45 people per night. We work closely with their staff to use our housing expertise to help lessen demand for their shelter by finding housing options for their residents.

Our program design is based on our experience successfully operating an HPRP-funded eviction prevention program. The City of New Rochelle asked HOPE to establish a Housing Outreach Center co-located with our emergency food programs and Hispanic outreach program as a base for providing HPRP rent-subsidies. HOPE's HPRP program proved particularly adept at budget counseling and helping people access job opportunities.

We will use a Housing First approach to offer eligible participants immediate access to permanent supportive housing. We use HUD Leasing funds to rent scattered-site units for clients who will pay occupancy charges not to exceed 30% of their income. We will work to stretch our CoC Leasing funds by layering them whenever possible with local- and state-funded Shelter Supplements that double the normal public assistance housing allowance for homeless people in Westchester. When we successfully help our residents secure these Shelter Supplements or other rent subsidies, we will be able to expand our program and serve more than 12 adults. HOPE Community Services will only lease units with gross rents at or under FMR including CoC funds, client occupancy charges, and other funding streams.

Our program will have a half-time Case Manager. We will help participants identify appropriate housing units and will inspect the units to ensure that they meet HUD's Housing Quality Standards. Our Case Manager will help participants learn how to manage money, develop realistic budgets, shop on a budget and cook, maintain their apartment, understand their rights and responsibilities as tenants, etc. Our Case Manager will provide crisis intervention services, help resolve landlord/tenant disputes, and address any issue that may cause a return to homelessness.

Our Case Manager will assess each resident's needs and negotiate a detailed Independent Living Plan. Our Case Manager will link residents to treatment for chemical dependency and/or mental illness, educational and vocational services, medical care and other community supports. Our Case Manager will help residents access mainstream benefits including food stamps and SSI. Our Case Manager will also help residents access housing subsidies including county/state-funded Shelter Supplements, HOPWA, Housing Choice vouchers, or HUD-VASH.
