We are still in the first quarter of the current FY2022 grant which began 06/01/23.
We usually make monthly claims, but the main factor which has prevented submission of claims to HUD so far during the first quarter of the current FY2022 grant is delays in executing the Grant Agreement with HUD and then the subcontract with the subrecipient.

DSS did not receive the Grant Agreement from HUD until June 29, 2023, four weeks after the beginning of the grant operating period. The late Grant Agreement delayed the rest of our contracting process, and subcontracting is still in process.

Once subcontracting is completed, we will make the initial claim for grant funds in LOCCS and we expect monthly claims for the rest of the grant period. DSS hopes that the FY2023 Grant Agreement is made available by HUD before the beginning of the renewal grant period.

The FY2021 grant Homestead NY0478L2T042114 had a tiny remaining balance of \$1,308.63 (0.25% of total award), including \$1,290.03 in Administration due to slightly lower than expected DSS staff costs.

This project provides safe, accessible and secure permanent supportive housing for 28 physically disabled homeless adults. According to HUD, such persons constitute 14% of those who are currently homeless, yet this is the only permanent supportive housing project in Westchester that specifically targets this under-served population and addresses this group's unique needs. We will use a Housing First approach to offer eligible participants immediate access to permanent supportive housing.

Our project provides group living in 4 three-bedroom apartments and 8 two-bedroom apartments. Each client has his/her own bedroom and shares a living room, kitchen, and dining room with one or two other clients. All units meet or exceed state and local housing codes. All of the tenants are disabled due to physical illnesses that may be compounded by mental illness or substance abuse issues, and may require home care at some level.

Clients will be connected to primary healthcare providers and will receive case management, social work assessments and home care services from Family Service Society of Yonkers. We find, lease, and inspect apartments to ensure compliance with all regulations for the disabled. Staff will be trained in all aspects of service needs of the physically disabled population, and provide outreach, peer support and advocacy services for all program participants.

VAWA Budget

New in FY2023, the Violence Against Women Act (VAWA) has clarified the use of CoC Program funds for VAWA eligible cost categories. 
