Project Overview: Greyston Health Services, Inc. is seeking renewal funding for Issan House, our 35-unit permanent supportive housing facility for formerly homeless men and women living with HIV/AIDS, many of whom also have a drug addiction and/or severe and persistent mental illness. Past access to these funds has positively impacted our ability to help our clients maintain housing stability and improve their health care.

Proposed Methodology: This project will serve adults living with HIV/AIDS who are formerly homeless. We will use a Low Barrier approach to offer eligible participants immediate access to permanent supportive housing. The majority of Issan House residents are also affected by substance abuse and mental illness. When a new client moves into Issan House, s/he is immediately engaged in services by Greyston staff, who complete an intake and assessment, as well as a psychosocial evaluation.

Greyston takes a client-centered approach to the services we provide and therefore involves tenants in the process of creating an individualized service plan. Services offered and made available to each Issan House tenant include: supportive individual and group counseling, mental health services, substance abuse/alcoholism counseling, crisis intervention, entitlements advocacy, socialization services, peer education and support, spiritual counseling, legal referrals, nutritional counseling including three meals per day, fitness training, and job readiness. We also provide 24-hour security. Issan House makes safe and affordable housing available to those who would otherwise be homeless or at risk of homelessness.
