Children's Village (CV) operates this transitional housing program for 12 young adults ages 18-24 who are homeless as defined by HUD homeless criteria. CV leases three 4-bedroom units at the Bay House site in Yonkers for this program, with private bedrooms for each client, a staff office, kitchen, laundry, and a backyard. Young adults will benefit from on-site services, supervision, and peer support offered by the congregate site.

The goal of Stepping Stones is to prepare homeless young adults for independent living and put them on the path towards economic self-sufficiency. THYA has adopted the First Place for Youth model, My First Place (MFP). The program provides Education and Employment tools that help advance education and uncover career paths in alignment with youth interests and strengths by utilizing the CASAS, RIASEC, Learning Styles and Job Readiness assessments. Housing and Healthy living interventions prepare youth for good tenancy, teach them to maintain housing, improve well-being, and support healthy, stable relationship building through unit inspections, monthly budgeting and life skills tracking. There is an Action Planning process for developing youth-driven plans that assist in developing and tracking youth goals and accomplishments and a data reporting system, Apricot, to track progress and outcomes. An assigned Youth Advocate/Case Manager provides services through supports such as individual case management, life skills training and community based referrals. An assigned Education & Employment Specialist will explore job training/employment services and educational advancement/resources with program participants. The range of services to be offered to each participant will be driven by data collected in real time.

Youth also complete the Ansell-Casey Life Skills Assessment which has nine domains for Independent Living Skills: Daily Living-Self-Care, Work and Study Skills, Social Relationships, Housing and Money Management, Communication, Home Life, Work Life, and Career Planning. All participants complete Evidence-informed assessments at baseline, that help determine needs, strengths, and progress toward outcomes, and in-program every six months thereafter to pinpoint each of their needs, assess the effectiveness of the life skills training they receive, and evaluate their progress. Exit assessments are performed to show youth their progress at program completion and can utilize the information given post-program. A Housing Specialist assists youth with housing applications, accompanies clients to housing appointments and interviews and teach youth how to search, obtain and maintain housing.

The project will provide participant youth with services to facilitate long-term economic independence and stable housing, and referrals to community services and resources that help them develop into healthy, productive adults.

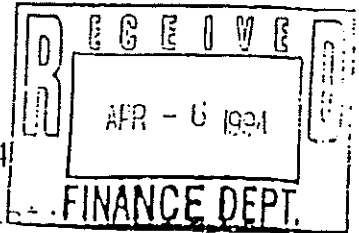
