MHACY was delayed in submitting claims to HUD for the current Yonkers RA grant NY0496L2T042215 which started 02/01/23 because MHACY received the Grant Agreement from HUD on June 14, 2023 – over four months after the start of the operating period. MHACY returned the executed copy to HUD on the same day, June 14 and immediately began subcontracting with subrecipients. The grant funds were then made available in LOCCS and MHACY made our first claims on July 19 and 20, 2023 based on vouchers we had reviewed and approved while waiting for the Grant Agreement from HUD.

We have made two subsequent claims in month since the initial draws and we will maintain at least monthly claims every month for the rest of the grant period.

We hope that any renewal Grant Agreement is forwarded to us next year before the start of the FY2023 grant period.

Yonkers RA NY0496L2T042013 had remaining a balance of \$27,700.82 in Rental Assistance and \$27,727.23 in the Administration line (total unspent was 8.56% of awarded funds). Unspent Rental Assistance was primarily due to grant savings from client share of rent - despite the fact that the project was significantly over 100% capacity for the entire grant period. Unspent Administration funds was due to MHACY and both subrecipients efficiently administering this project without needing additional staff time for Administration tasks.

The Municipal Housing Authority for the City of Yonkers has successfully operated the City of Yonkers first Shelter Plus Care (Rental Assistance) Program since 1995. This grant funds 33 units (48 beds) of permanent supportive housing for individuals those with a history of addiction, mental illness and those living with HIV/AIDS.

Subrecipient providers Westhab and Mental Health Association of Westchester provide intensive case management, needs assessment, and life skills training to enable project participants to maintain their permanent housing. Other supportive services such as health care, home care, and supportive counseling are arranged as needed from among the 120+ private and public agencies with which we have already established linkages.

We will use a Housing First approach to offer eligible participants immediate access to permanent supportive housing. All residents are given a psycho-social assessment at enrollment to determine the types of services needed and types of issues that must be addressed in order to maximize each participant's ability to retain permanent housing. The primary emphasis of our program is on linking participants to chemical dependency treatment and other services that directly address the factors that have led to participants' previous episodes of homelessness. Westhab and MHAW Case Managers work with each resident to develop an Individualized Service Plan that addresses these needs and issues. The Case Manager follows-up to resolve any problems that arise that could threaten housing stability.

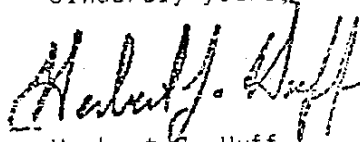
